Reference No. 518-P.D./Commr./16-17 dated 05.01.2017 of Commissioner, Howrah Municipal Corporation and No. 527-P.D./16-17 dated. 10.01.2017 of Personnel Officer Howrah Municipal Corporation regarding deployment of Mayor's Cop, Supervisors, Disaster Management Group personal to Howrah City Police.

To improve civic services of residence of Howrah Municipal Corporation in general with a specific objective, 163 numbers contractual staff of HMC who were engaged as Mayor's Cop including 40 number supervisors and 12 number Disaster Management Group have been detailed to Howrah City Police in different units as per enclosed chart. They will be utilized by Howrah City Police and Howrah Municipal Corporation. They will perform the following works :-

- 1.
- i) To inspect conditions of roads of the respective ward, allotted to him / her.
- ii) To inspect conditions of Trident lights and other lights of the same ward.

- iii) To inspect if any water body is being filled up illegally.
- iv) To inspect if any unauthorized building are being constructed.
- v) To inspect the quality of conservancy services in the ward.
- vi) To report if there is any irregular supply or connection of water in any part of the ward.
- vii) To assist the city police regarding Traffic Control, Disaster Management Duties, as Vector Control duties as a part of Health Team and allied works.
- viii) For keeping vigilance in their area regarding Law & order etc.
- ix) They may be utilized by the Howrah City Police under close vigil for survey of existing Hawkers, Goomtees at their respective wards.
- x) Other duties as would be entrusted by the authorities of HMC and Howrah City Police.

2. The personal, deployed at Traffic Guards will perform traffic duties at least 02 hours in the morning and 02 hours in the evening in peak hour at their respective Traffic Guard Jurisdiction. After that they will look after their HMC related works as specified in SL No. 01 in their respective wards and will submit a daily report through OCs of respective TGs to the office of the Mayor, HMC through proper channel.
3. The personal, deployed at Police Stations, Special Branch etc. will be utilized by respective units -in- charge for collecting intelligence of their areas for 2/4 hours. After that they will look after their HMC related works as specified in sl no. 01 in their respective wards and will submit a daily report through OCs of respective PSs and DCP (SB), HPC to the office of the Mayor, HMC through proper channel.
4. The personal, deployed in Health / Vector Control Team will be stationed at Shibpur Police Lines under charge of Reserve Inspector and will perform in co-ordination with HMC to prevent Malarial, Dengue activities at different campus of PSs, TGs, Police Housings, Police lines under HMC area for 2/4 hours. After that they will look after their HMC related works as specified in sl no. 01. in their respective wards and will submit a daily report through RI, HPC to the office of the Mayor, HMC through proper channel.
5. The personal, deployed in Disaster Management Group will be stationed at Shibpur Police Lines in shift under Charge of Reserve Inspector and will be utilized as per necessity, they submit a daily report about the problem of their respective wards through RI, HPC to the office of Mayor, HMC through proper channel.

6. The units-in-charge of Howrah City Police, where Mayor's Cop, Supervisors, Disaster Management Group & Vector Control / Health Team personal will be engaged will submit a work certificate by the 15<sup>th</sup> day of each month to OC CV Cell, HPC / TI (HQ), HPC, so that a consolidated work certificate can be submitted by OC CV Cell, HPC to HMC by 20<sup>th</sup> of every current month for their wages / salary from HMC.

- Individual listeners of logger unit will directly report to the concerned OCs of sections directly without delay regarding information. The OCs of the sections will communicate the information to the superiors if need be by whatsapp/SMS/Phone. Only with regard to interception relating to the communal issues, the feedback will directly go to Inspector DD, HPC.
- Under normal circumstances, each section with its allotted manpower will focus exclusively on his area of work and spend a greater part of their time outdoors and will try to cultivate manual sources.
- No detailment is to be done for law and order duties without consulting the DCP Zone -II looking after the work of DD. Only those persons released by them will go for the mentioned law and order duties.
- Nothing shall prevent the OC of one section to take help of manpower or resources etc. from another section with the consent of the OC of the section after informing senior officers.
- The category of priority to the different work in the section shall be solely determined by the respective OCs unless otherwise specifically told to do otherwise by their respective superiors.
- ACP, DD, HPC will also supervise the correspondence in DD, HPC including signature of interception letters.
- For any requirement like SDR, CDR, the concern unit in-charge must immediately send an e-mail to OC, Logger, so that immediate action may be taken. The request for SDR & CDR will continue to be sent as previously in the e-mail id howrahpolice-wb@nic.in. Interception letters will be sent through hard copy by the concerned unit-in-charge. Interception letters will not be sent through e-mail.


