Memo No. 230(48)/CP Dated: 05.03.2024.

In view of the public safety and convenience in connection with visit of the Hon'ble Prime Minister of India to the city of Kolkata on 05.03.2024 and 06.03.2024, it is informed by Kolkata Police vide Traffic Notification No TP/14 dated 04.03.2024 of Commissioner of Police, Kolkata that on those particular days No Goods Vehicles will be allowed to enter into the jurisdiction of Kolkata Police from 16.30 hrs to 21.40 hrs on 05.03.2024 and again from 07.30 hrs to 13.00 hrs on 06.03.2024 or till the journey of the VVIP is over. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, *IPS*, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules -

Restrictions for Goods Vehicles:

Movement of all types of Goods Vehicles shall be prohibited to ply along various roads towards Kolkata City from 16.30 hrs to 21.40 hrs on 05.03.2024 and again from 07.30 hrs to 13.00 hrs 06.03.2024.

THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THE DAYS, WHICH ARE NOT REPUGNANT TO THE ABOVE.

Whereas for preventing danger, obstruction or inconvenience to the public in connection with the 'Mass Rally' by All India Trinamool Congress Committee at Brigade Parade Ground, Kolkata on 10.03.2024, it is informed by Kolkata Police vide Memo No.TCR/91/2024 dtd. 05.03.2024 of Deputy Commissioner of Police, Traffic Kolkata Police, it is necessary in the interest of Public safety, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate area. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue following restriction order as per following time schedule on the following roads --

Date & Time -

On 10.03.2024 from 02:30 hrs. to 20:00 hrs.

<u>Restrictions for all types of Goods Vehicles (</u>except LPG vehicles, Vegetable, Fruits & Milk carrying vehicles)

- 1. Nimtala crossing towards Bally along GT Road.
- 2. Ballykhal Island towards Bally along GT Road.
- Bamundanga Island towards Bally & Dakshineswar along GT Road & Vivekananda Setu.
- 4. NH-2 & NH-6 Xing towards Nibedita Toll.
- Near Salap More towards Dasnagar along Howrah Amta Road on Kabardanga more.
- Kona more on NH 6 towards Liluah along Benaras Road towards Jagadishpur.

- 7. Kazipara Crossing towards Kolkata & towards Howrah via 2nd Hooghly Bridge and GT Road.
- Near Alampur More towards 2nd Hooghly Bridge along Andul Road.
- Hung Sung Crossing towards Drainage Canal Road and 2nd Hooghly Bridge.
- Kona Truck Terminal towards Kolkata & Howrah City side along Kona Express way and 2nd Hooghly Bridge.
- Near Nibra More to towards Kolkata & Howrah City along Kona Express way and 2nd Hooghly Bridge.
- 12. Howrah & GT Road bound via 2nd Hooghly Bridge & Kona Express way.

In addition to the above, no Goods Vehicles will be allowed to ply within this Commissionerate area from 02:30 hrs to 20:00 hrs. on 10.03.2024.

Restrictions for all other vehicles:

All Panchanantala bound passenger vehicles will be diverted from Sarat Statue at GR Road towards Fish Market via IC Bose Road, CM Bridge, GT Road, Phansitala, Panchanantala at Howrah.

No vehicle will ply along M.G. Road, Church Road, Nityadhan Mukherjee Road.

Restrictions of slow moving vehicles:

Slow moving vehicles will be restricted to ply along Foreshore Road, G.T. Road, Panchantala Road, N.S. Road, Grand Foreshore Road, Girish Ghosh Road, Aravindo Road, J.N. Mukherjee Road, Andul Road, Drainage Cannel Road, East -West Bye Pass Road from 9 AM to 12 PM on 10.03.2024.

These regulations will remain in force in addition to the other normal traffic restrictions on the day (10.03.2024), which are not repugnant to the above.

ORDER

Memo No. 255(60)/CP, HPC

WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur Police Station) in the town of Howrah (hereinafter referred to as the said areas)

And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974)

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 144 of the Code of Criminal Procedure, 1973 (Act. 2 of 1974) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the 11th March, 2024 to 09th May, 2024 until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

The area within the jurisdiction of Shibpur Police Station in the town of Howrah bounded -

1) On the North by - Haradeb Bhattacharyay Road upto and including Mandirtala Bus Stand.

2) On the East by - Khetro Banerjee Road, Nabin Banerjee Lane, A K Roy Chowdhury Lane and Mollapara Lane upto G T Road crossing including Kazipara Morh. Hiralal Banerjee Road, Dinu Master Lane, Mollahpara Lane upto G.T. Road Crossing (D.B. College), Danesh Mollah Lane upto G T Road crossing.

On the West by - K. M. Banerjee Road, Circular 2nd Bye Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road upto old 58 Bus stand.

4) On the South by - Tarapada Chatterjee Road, Upen Chatterjee Road upto Betaitala More.

All the ramps of Vidyasagar Setu on Howrah side.

5) Explanation - In this order, the Town of Howrah means the town of Howrah as defined in Section 2(15) and Schedule - I of the Howrah Municipal Corporation Act, 1980 (Act of 29 of 1980).

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub Sec (1) read with sub Section(3) of Sec-144 of the Code of Criminal Procedure-1973 (2 of 1974), I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act u/s-144 of the said code do hereby prohibit the assembly of five(5) or more persons within the radius of 100 (hundred) meters of the periphery of all the above mentioned examination centres within the Metropolitan area of Howrah from 06:00 hrs. to 18:00 hrs on the days of examination, i.e. on 16.03.24 & 17.03.24.

And all the **Photo Copying Centres** operating **within 100 (hundred) meters** from all the **examination centres** stated above **shall not be allowed** to operate **from 06:00 hrs. to 18:00 hrs** during the examination mentioned above on the aforesaid days.
