NOTIFICATION

Whereas for peaceful completion of Load Testing purpose the Rishi Bankim Setu Ramp from opposite to Howrah Bus Stand under PS Golabari (approx 90 Mtr) and ramp up to Volley Ball Ground from Bangabashi towards New Cab Road, PS - Howrah (approx 115 Mtr) shall remain closed for vehicular traffic from 05:00 hrs on 23.08.2019 to 24:00 hrs on 25.08.2019. Vehicular circulation will be made in the following manners during this period to facilitate the said work, it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the work, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah.

I, Gaurav Sharma, IPS, Commissioner of Police, Howrah, in exercise of power conferred upon me u/s 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated. 01.09.2011 of Transport Department, Govt. of West Bengal, the following order, on the following stretch of road and time as mentioned hereunder.

Diversion of all type of vehicles including route & long distance Buses:

- All Shibpur bound vehicles will be diverted from Howrah Railway Station Road to avail Foreshore road via Rail Museum.
- All Howrah Maidan bound vehicles will be diverted from I.C. Bose Road (Fish Market Road) right turn Hari Mohan Bose Road to avail R.B. Setu.

- iii) All Panchanantala and Fansitala bound vehicles will be diverted from I.C. Bose Road (Fish Market Road) left turn to avail C.M.Bridge.
- iv) All North Howrah bound vehicles will avail Dobson road via Fish market on their existing route.
- v) All Long Distance Bus will be diverted from Howrah Railway Station Road to avail Foreshore road via Rail Museum.
- vi) All existing one way restriction will continue during the closure. Only one portion of G.T.Road on C.M. Bridge from Hari Mohan Bose Rd. and GT Road crossing to Fansitala will be open for two way vehicular traffic movements.
- vii) All vehicles coming via GT Road towards Bangabashi will avail RB Setu Ramp besides Bangabashi Patrol Pump under PS - Howrah towards New Cab Road and take left turn proceed through cut out towards Howrah Bridge.

This order shall come in force from 05:00 hrs. on 23.08.2019 to 24:00 hrs. on 25.08.2019.

Whereas for peaceful completion of Permanent restoration work along Andul Road from Hanskhali Pool to Danesh Sk. Lane crossing (Total distance about 1.60 Km) will be started from 31st August 2019 To 25th September 2019, it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the work, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate during the period.

I, Gaurav Sharma IPS, Commissioner of Police, Howrah, in exercise of power conferred upon me u/s 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, Govt. of West Bengal, the following order, on the following stretch of road and time as mentioned hereunder,

Restriction Period & Type of Restriction :

- 1) **20:00 hrs.- 06:00 hrs.- everyday**
 - i) No entry for heavy goods vehicles from Alampur crossing and Nazirganj (Satyen Bose Road) side towards 2nd Hooghly Bridge on those stipulated date and time.

- ii) Same will be enforced from 2nd Hooghly Bridge side towards Andul Road.

2) 24 hours.- everyday

No Heavy Goods vehicle will be allowed from Alampur crossing and Nazirganj (Satyen Bose Road) side towards 2nd Hooghly Bridge on those stipulated date and time.

- 3) Vehicular traffic may also be diverted from any of the arterial roads and feeder roads by the traffic police on duty as and when considered necessary on those days.
- 4) These regulations shall be enforced in addition to the others normal restrictions on those days, which are not repugnant to the above.

This order shall come in force from **31st August 2019 to 25th September 2019.**
