In order to strengthen the existing law & order set up at Police Stations, it has been decided to constitute the post of O/C Anti Crime in all Police Stations of Howrah Police Commissionerate area. Accordingly, it is proposed to designate one senior Sub-Inspector in each Police Station of the Commissionerate as O/C Anti Crime who shall be empowered to tackle immediate issues of law & order and crime concerning the respective Police Station area.

The roles and responsibilities of each O/C Anti Crime Officer shall include the following:-

1. Crime related matters.
2. First responder of Law & Order of the area.
3. Intelligence gathering with respect to Political and Communal scenario.
4. Any other issue as delegated by IC/Divisional ACP.

The O/C Anti Crime of each Police Station shall be reporting to the respective Inspector-in Charge of Police Station for the time being in force. The Divisional Assistant Commissioners of Police/Deputy Commissioners of Police may also directly supervise the functioning of O/C Anti Crime.
