In partial modification of all orders passed in earlier occasion, the following order is passed for proper regularization of leave/overstay from leave / unauthorized absence of Police personnel.

1. Henceforth, if any Police personnel (SI downwards) of Howrah PC are found absenting unauthorizedly or overstaying from leave for more than one month, considering the gravity/genuineness, his/her pay may be kept held over till his return/resume in Govt. duty. On his/her return, his/her case will be decided in the Orderly Room, Part-I of the respective DCsP [North(Zone-I)/South(Zone-II)/Traffic/SB] and accordingly his/her held over pay will be released followed by the order of DCsP [North(Zone-I)/South(Zone-II)/Traffic/SB].
2. PA / Reader to DCsP [North(Zone-I)/South(Zone-II)/Traffic/SB] will communicate the orders of respective DCsP, to RO, Leave from time to time for entering the fact in CO and taking other administrative actions thereby according to the prevailing orders / rules / regulations.
3. ROs (Leave/Pay) will act accordingly on receipt of the orders from DCsP [North(Zone-I)/South(Zone-II)/Traffic/SB].


