ORDER

Whereas for peaceful observance of SNAN-YATRA of SITALA MATA festival to be celebrated on 08.02.2020 it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the YATRA, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate during the period. In exercise of powers conferred upon me U/S 112(2)/115/ 116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Kunal Aggarwal, IPS, Commissioner of Police, Howrah do hereby issue the following restrictive orders as per the following time-schedules on the following roads.

Restrictions for Goods Vehicles:

Movement of goods vehicles will be restricted from 02:30 hrs on 08.02.2020 to 08:00 hrs on 09.02.2020 on the following roads:

- 1) From Bamundanga Island on NH-2 up to Nimtala crossing.
- 2) From Nimtala crossing towards Bally along GT Road.
- 3) From Ballykhal Island towards Bally along GT Road
- 4) From Liluah Flyover Crossing towards Matawala Chowrasta.
- 5) From Kona Crossing on Benaras Road towards Bamungachi Bridge.
- 6) From Chatterjee para Crossing on Natabar Pal Road up to Belgachia Crossing on Benaras Road.
- 7) Bamungachi Bridge on Benaras Road.
- 8) 'A' Road & Jhil Road under Liluah PS.

Restriction for All types of vehicles:

The movement of all types of vehicular traffic will be remain suspended on the following roads from 11:00 hrs. on 08.02.2020 till completion of SNAN-YATRA.

- 1) From Pilkhana Crossing towards Salkia Crossing along G T Road.
- 2) From Salkia Crossing towards Bandhaghat and vice-versa.
- 3) From Naskarpara Road and G T Road Crossing, in front of T L Jaiswal Hospital towards Salkia Crossing.
- 4) From Liluah Station Road Crossing towards Salkia crossing.
- 5) From Kalitala Crossing along J N Mukherjee Road towards Bandhaghat & from Bandhaghat to Nayamandir along Salkia School Road.
- 6) From Belur Bazar along Lal baba shaire Road & Girish Ghosh Road up-to Bandhaghat via Kalitala Crossing.
- 7) From Matawala Chowrasta towards G T Road along Dharmatala road & Ahmed Mamuji Road.
- 8) From Dobson Road & Dr Abani Dutta Road Crossing towards G T Road and along Bijay Mukherjee Road towards G T Road.
- 9) From Chatterjee para towards Belgachia along Natabar pal road.
- 10) From 'A' Road Crossing - towards Belgachia along Benaras Road.
- 11) From Raghav koley Lane - towards Belgachia along Benaras Road.
- 12) From Dasarath Ghosh Lane and Benaras Road Crossing-towards Belgachia along Benaras Road.
- 13) From Salkia School Road & Upendra Mitra Lane Crossing towards G T Road via Jelia para Lane and vice-versa.
- 14) From Ram Seeta Mandir & Salkia School Road Crossing towards G T Road and Upendra Mitra Lane.

ORDER

WHEREAS, a large number of commercial places, network service providers and shops have come up in the Metropolitan area of Howrah as notified in this behalf, in the popular name Cyber Cafe,

AND WHEREAS, a large number of people frequently visit these Cafes to use the internet, computer network facilities available in those cyber cafes,

AND WHEREAS, there is every likelihood that the said facilities might be used by persons knowingly or intentionally to mislead the security and investigating agencies, commit offence as defined in Chapter-XI of the Information Technology Act, 2000 (21 of 2000), create panic in the public, help in anti-national activities affecting security of the state,

AND WHEREAS, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury, annoyance to persons etc.,

NOW THEREFORE, in exercise of the power conferred by sub-section (1) read with sub-section (3) of section 144 of the Code of Criminal Procedure, 1973(2 of 1974), I, Kunal Aggarwal, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government Home (Police) Department Order No. 3636-PL/PB/14M-138/04 dt. 26.08.2011 to act under Section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), do hereby order, the owners of the said cyber cafes and persons having

management of those cyber cafes to follow the followings in respect of those cyber cafes, viz. :-

- a) Prohibiting the use of cyber cafe by unknown person and whose identity has not been established before the owner of the cafe.
- b) Maintaining a register for identity of the visitors or users.
- c) Make an entry in the handwriting of the visitors or users maintaining name, address, telephone number and identity proof. The visitors/users shall also sign the register kept for this purpose.
- d) The identity of the visitors or users shall be established through Identity Card, Voter Card, Ration Card, Driving License, Passport and Photo Credit Card (any one of them).
- e) Activity server log should be preserved in main server and its record should be preserved for at least six months from the point of last use.
- f) If any activity of any visitors or users is of a suspicious nature, the owner of Cyber Cafe shall immediately inform the nearest Police Station.
- g) Record be maintained about the specific computer used by the visitor or user.

This order shall come into force on and from **14th day of February, 2020** and remain in force for a period of 60 (sixty) days i.e., upto **14th day of April, 2020** unless rescinded or altered earlier.

Any person contravening this order, is liable to be punished under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned the order is hereby passed ex-parte. It shall be published for the information of public through press and by affixing copies on the notice boards of the offices of all Divisional D.Cs.P, ADCP (South Divn.), all Divisional A.Cs.P and all Police Stations concerned;

ORDER

WHEREAS, from the reports received so far, there is sufficient ground to apprehend that the terrorists or anti-social elements may seek hideouts in the residential areas of the Police Stations, falling under metropolitan area of Howrah,

AND WHEREAS, there is every likelihood of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety and injury to public property on that account,

AND WHEREAS, it is felt necessary that some procedural safeguards should be put on tenancy or licensing process prevailing, so that terrorists or anti-social elements in the guise of tenants may not get tenancy or license for residential purpose and to cause disturbance or public tranquility or danger to human life or safety to public at large,

AND WHEREAS, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury, annoyance to persons etc.,

NOW THEREFORE, in exercise of the power conferred by sub-section (1) read with sub-section (3) of section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), I, Kunal Aggarwal, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government Home (Police) Department Order No. 3636-PL/PB/14M-138/04 dt. 26.08.2011 to act under Section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), do hereby order that no land-lord or owner or person whose property falls under the jurisdiction of area of any of the Police Stations under Howrah Metropolitan area shall let/sublet/lease/rent out any residential accommodation or grant lease or license to any person unless and until the said landlord/owner/person has furnished the particulars of the said tenant(s)/ license as the case may be as per the Proforma in Schedule-I to the Officer -in-Charge of the Police Station concerned. And whoever having property in his possession or under his management shall also inform in writing to the Officer-in-Charge of the Police Station concerned in whose jurisdiction the premise falls about the particulars of the tenants or leasee or licensee as the case may be as per the said proforma.

This order shall come into force on and from **14th day of February, 2020** and remain in force for a period of 60 (sixty) days i.e., upto **14th day of April, 2020** unless rescinded or altered earlier.

Any person contravening this order is liable to be punished under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned the order is hereby passed ex-parte. It shall be published for the information of public through Howrah Police Gazette, Official Website of Howrah City Police and by affixing copies on the notice boards of the offices of DCP, Zone-I (North Division), DCP, Zone-II (South Division), ADCP (South Division), Divisional ACPs and all Police Stations concerned and the Offices of Howrah Municipal Corporation.

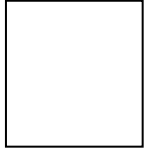
