ORDER

Memo No. 178(39)/Elec/HPC

Dated. 10.03.2019

Whereas, the **General Election to Lok Sabha 2019** in the District of Howrah has been declared vide Press Note No. ECI/PN/23/2019 dtd.10/03/2019 by the Election Commission of India.

AND

Whereas, as per the Election Commission of India vide Press Note No. ECI/PN/23/2019 dtd.10/03/2019 the Commissioner of Police, Howrah must consider asking the licence holders of Firearms to deposit the arms till the completion of the Election process.

AND

Whereas, in order to conduct the ensuing **General Election to Lok Sabha 2019** in the Metropolitan area of Howrah peacefully, it is expedient to impose restriction on the holding of licensed arms.

AND

Whereas, on assessment of license holders and licensed arms in the Metropolitan area of Howrah by screening committees as constituted by the Election Commission of India in its Memo No. 464/INST/2009/EPS dtd. 01/09/2009.

I, **Vishal Garg, Commissioner of Police, Howrah** in exercise of power conferred upon me u/s 17(3)(b) of the Arms Act 1959 (Act No. 54 of 1959) and the Arms Rules, 2016 read with the Indian Arms Act 1878, do hereby suspend all the licences of Firearms within the Metropolitan area of Howrah till the process of General Election to Lok Sabha 2019 is over and direct as per Sec 21(1) of the said Act that all the licensee of Firearms within the Metropolitan area of Howrah shall mandatorily deposit their Firearms with the respective Police Stations or licenced arms dealers within 07 (seven) days from the date of receipt of notice and same will remain deposited there till one week after the declaration of the result of the **General Election to Lok Sabha 2019**.

Gun licence holder may apply for exemption from this order to the under signed through the concerned police station making out their cases with appropriate documents/justification.

Further order is passed to the effect that the respective Officer-in-Charge of Police Station shall deposit the Firearms of the licensee in the armory of the Police Station under a proper acknowledgement to the licensee or keep record of deposition of arms with licensed arms dealers and will hand over the said Firearms to the licensee after one week after the declaration of the result of **General Election to Lok Sabha 2019** in the Metropolitan area of Howrah. List of any Firearms, remaining with the police station shall be sent to the Commissioner of Police, Howrah thereafter for appropriate action.
