Whereas it is necessary for preventing danger, obstruction or inconvenience to the public to regulate traffic of all kinds during the **Kali Puja festival on 14.11.2020** and during Kali Puja immersion days I, Kunal Aggarwal, IPS, Commissioner of Police, Howrah in exercise of the powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department do hereby issue the following restrictive orders as per following time schedule on the following roads :-

(I) In the interest of public safety and convenience the movement of Goods Vehicle shall be prohibited to ply towards Kolkata as well as within Howrah City as per the following schedule on the following roads -

From 15:30 hrs. on 14.11.2020 to 03:30 hrs. on 15.11.2020.
From 15:30 hrs. on 15.11.2020 to 03:30 hrs. on 16.11.2020.
From 15:30 hrs. on 16.11.2020 to 03:30 hrs. on 17.11.2020.
From 15:30 hrs. on 17.11.2020 to 03:30 hrs. on 18.11.2020.

1. Nimtala crossing towards Bally along GT Road.
2. Ballykhal Island towards Bally along GT Road.
3. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally.
4. NH2 & NH6 crossing towards Nibedita Setu.
5. 'O' point towards Old Bally Bridge / Nibedita Setu.
6. Near Salap Morh towards Dasnagar along Howrah Amta Road.
7. Near Salap Bazaar towards Dasnagar along Howrah - Amta Road.
8. Kona Morh on NH6 towards Liluah along Benaras Road.
9. Kazipara crossing towards Kolkata & towards Howrah via 2nd Hooghly Bridge & GT Road.

15. Kona Truck terminal towards Kolkata & Howrah City along Kona Express way & 2nd Hooghly Bridge.
16. Near Nibra Morh towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
17. From Betaitala towards Fore Shore Road and GT Road.

(II) In the interest of public safety and convenience the movement of all vehicle shall be prohibited to ply within the Howrah Police Commissionerate area as follows :-

3. A - Road under Liluah PS towards Belgachia Kona More.
4. Panchanantala Morh on GT Road towards Phansitala, East-West Bypass, GT Road & Church Road.
5. Rail Museum Crossing on Grand foreshore Road towards Burn Standard More on immersion days i.e. 15.11.2020, 16.11.2020 & 17.11.2020.
6. Banshtala Ghat More on Foreshore Road towards K C Dutta Road and Gangadhar Mukherjee Road on immersion days i.e. 15.11.2020, 16.11.2020 & 17.11.2020.
7. All North bound vehicles starting from Kazipara Crossing towards Belur Bazaar will move from South to North via GT Road till midnight.
8. All South bound vehicles starting from Belur Bazaar will move from North to South via Lalababa Saire Road, Girish Ghosh Road, J N Mukherjee Road, Arobinda Road towards Benaras Road and GT Road, CM Bridge, Phansitala to Church Road or East West Bypass.

(IV) The above regulation shall be enforced in addition to the normal restrictions which are not repugnant to the above.

1. Nimtala Crossing towards Bally along GT Road.
2. Ballykhal Island towards Bally along GT Road.
3. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally.
4. NH2 & NH6 crossing towards Nibedita Setu.
5. 'O' point towards Old Bally Bridge / Nibedita Setu.
6. Near Salap morh towards Dasnagar along Howrah Amta Road.
7. Near Salap bazaar towards Dasnagar along Howrah - Amta Road.
8. Kona morh on NH6 towards Liluah along Benaras Road.
9. Kazipara Crossing towards Kolkata & towards Howrah via 2nd Hooghly Bridge & GT Road.
10. Coal depot towards Howrah along Foreshore Road.
11. Tollplaza towards Kolkata via 2nd Hooghly Bridge and Kazipara.
12. Ramp of 2nd Hooghly Bridge towards Mandirtala and Kazipara.
13. Near Alampur morh towards 2nd Hooghly Bridge along Andul Road.
14. Hung-Sung Crossing towards Drainage Canal Road & 2nd Hooghly Bridge.
15. Kona Truck terminal towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
16. Near Nibra morh towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
17. All kinds of goods vehicles will be restricted within Bally & Howrah Municipal area as per time format mentioned above.

(II) In the interest of public safety and convenience the movement of all vehicles shall be prohibited to ply within the Howrah Police Commissionerate area as follows:-

From 11:30 hrs. to 22:00 hrs. on 20.11.2020.
From 02:30 hrs. to 12:00 hrs. on 21.11.2020.

1. All type of vehicles entry and parking From Banstala Ghat to Rail Museum on Grand Foreshore road.
2. Goods vehicle Entry & Parking within HRS TG area during Chhat Puja.
3. No vehicle will proceed towards Rail Museum & Burn More from Station area.
4. From Fazir Bazar Crossing towards Banstala Ghat Crossing along Gangadhar Mukherjee Lane.
5. All type of vehicles entry and parking from Coal Depo to

towards Shibpur burning Ghat and river side road up to Shibpur launch Ghat road and Foreshore road crossing.

(III) The vehicular traffic shall be diverted to ply within the Howrah Police Commissionerate area as specified below at the following roads –


